THIS AGREEMENT entered into by and between the owners of lots in Lafayette Place Addition to the City of Fort Wayne, Allen County, Indiana, who affix their signatures to this instrument or counter-part hereof, WITNESSETH That

WHEREAS, Lafayette Place Company on June 15, 1915 conveyed to Lee J. Ninde lots numbered 1 to 444, both inclusive, in Lafayette Place Addition to the City of Fort Wayne, Allen County, Indiana, by deed recorded in Book 236, on pages 491-498 of the Deed Records of said Allen County; and

WHEREAS, the aforesaid deed imposed upon all the lots therein described certain conditions, limitations and restrictions and provided a procedure for the enforcement thereof which enforcement procedure was in part modified by a waiver and release made by Lafayette Place Company on February 1, 1926 and recorded on February 3, 1926 in Release and Assignment Record 7, on page 296, of the Records in the Recorder's office of said Allen County; and

WHEREAS, said conditions, limitations and restrictions were calculated to be and have been beneficial to all the lots in said Addition and to the respective owners thereof; and

WHEREAS, two thirds of the resident owners of said lots were expressly authorized to change or abolish any of said conditions, limitations and restrictions:

Now, therefore, it is agreed by and between the parties hereto and their successors in interest, as follows:

1. That paragraph 16 of the aforesaid deed be and the same is hereby changed to read as follows: "16. All restrictions and conditions herein contained shall be valid and binding, and continue in full force and effect forever, provided, however, that such conditions and restrictions or any of them, may be changed or abolished in any or all particulars by the then owners of the lots in said Addition whenever two-thirds of the resident owners shall unite in

signing and executing an agreement or resolution to that effect, provided further that such signers shall number not less than 50, which agreement or resolution shall upon being recorded in the proper records in the Recorder's Office of Allen County, Indiana, be valid and binding upon the seller and owners of all of said lots, and upon all other persons."

2. That paragraph 4 of the aforesaid deed be and the same is hereby changed to read as follows:

"4. All of the lots in said Addition shall be subject to an annual maintenance charge of \$2.50 per lot to be paid by the owner of each lot on the 1st day of January, 1945, and on the 1st day of January of each year thereafter to Lafayette Place Improvement Association for the purpose of creating a fund to be known as a maintenance Fund and used by said Association as it may determine in caring for and maintaining said Addition and said Association shall have the right by a resolution of its Board of Directors to abolish and to re-establish said annual charge from time to time."

3. That in the event an insufficient number of resident owners join so as to effectuate the continuance as herein modified of all of said conditions, limitations and restrictions as to all of the lots in said Addition the provisions of this agreement shall be binding from the date of its recording upon all lots whose owners join herein and their successors and as to them said conditions, limitations and restrictions shall, as herein modified, continue in full force and effect provided, however, that this agreement shall not be recorded or become effective until and unless the owners of 250 lots have duly signed this agreement.

4. A counter part of this agreement shall be a copy hereof and any lot in said Addition whose owner signs any counter part shall be bound by the terms hereof to the same extent as if all the owners had signed the same instrument and all signatures and executions shall be appended to the original hereof for the purpose of recordation.
